

Privacy Policy for the “Coverage View” Mobile Application

1. Terms and Definitions

- **Device** – A mobile technical device running iOS or Android on which the “Coverage View” mobile application is installed.
- **User** – A natural or legal person using the “Coverage View” mobile application and interacting with its services.
- **App** – The “Coverage View” mobile application, accessible via Users’ Devices through the Internet.
- **Developer** – The developer of the “Coverage View” mobile application, Nikolay Zhuteyan.

2. General Provisions

2.1. The Privacy Policy for the “Coverage View” mobile application (hereinafter referred to as the Policy) applies to information that the Developer may obtain from the User’s Device during the use of the “Coverage View” mobile application (hereinafter referred to as the App).

2.2. Using the App implies the User’s agreement with the Policy and the terms of information processing specified herein. If the User disagrees, they should refrain from using the App.

2.3. The App and its services are provided to the User under agreements with companies that process and store Users’ personal data in compliance with the legislation of the Russian Federation.

2.4. The Policy applies solely to the App. The Developer is not responsible for any information (or its consequences) transmitted by the User to third parties if such transmission occurred on third-party resources accessed via links from the App. When using services involving the transmission of text and media data within the App, the Developer does not control the User’s content and does not initiate the transmission of such content or other information shared by the User within the App, and therefore bears no responsibility for it.

2.5. The Developer reserves the right to make changes to the Policy and publish them within the App. It is the User’s responsibility to review the latest version of the Policy independently.

3. Types of Information That May Be Collected Through the App

3.1. Information collected from the User's Device during the use of the App and its purposes (hereinafter referred to as User Information):

3.1.1. Device Information, for analyzing possible App errors and improving the App's performance:

- Operating system version;
- Device model;
- IP address and connection point address of the User;
- Cookies files.

3.1.2. Usage Information, for enhancing the App's performance and updating the App:

- Information on update results, including the type and unique identifier of the Device on which the App is installed, update identifier and version, update settings identifier, update results, and the OS version available for the App;
- Information about errors in the App's components, including error type, time of occurrence, and the identifier of the software component and task during which the error occurred;
- App version and identifier, unique Device identifier, type, and version of the installed OS.

3.2. Additionally, under this Policy, the Developer may use software tools to process anonymized statistical information about User interactions with the App and its services to improve the App. The Developer may share anonymized data about the OS and Device model with third-party organizations.

4. Conditions for Processing User Information

4.1. Under this Policy, the Developer processes only the information necessary for the purposes defined in Section 3.

4.2. The Developer takes all reasonable measures to protect User information from unauthorized access, use, copying, or distribution by third parties.

4.3. For the purposes outlined in this Policy, the Developer may involve Partners with whom the Developer has confidentiality agreements. Anonymized data about App usage may be shared with Partners to improve the App based on contractual agreements.

4.4. User information may be stored on Developer resources for the duration of contractual relationships between the Developer and the User regarding the App, and for an additional three years following the termination of such contracts.

4.5. User information may be disclosed to governmental authorities in compliance with the applicable laws of the Russian Federation.
